

**BY-LAW NUMBER 15-74**

**OF**

**THE CORPORATION OF THE TOWNSHIP OF CLEARVIEW**

**A By-Law to Change the Title of Certain Members of Council**

**WHEREAS**, Section 220 of the Municipal Act, 2001, S.O. 2001, chapter 25, as amended authorizes a municipality to change the title of its head of council or other members of Council; and,


**WHEREAS**, Council of the Township of Clearview passed By-Law Number 14-26 to change the title of Mayor and Deputy Mayor to Mayor/County Councillor and Deputy Mayor/County Councillor; and


**WHEREAS**, Council of the Township of Clearview passed a resolution at the September 14<sup>th</sup>, 2015 meeting to direct the Clerk to prepare a by-law to rescind By-Law 14-26, being a by-law to change the title of certain members of Council (Mayor/County Councillor and Deputy Mayor/County Councillor).

**NOW THEREFORE** the Council of the Corporation of the Township of Clearview **HEREBY ENACTS** as follows:

1. That By-Law 14-26 be rescinded.
2. That the title Mayor/County Councillor be changed to Mayor
3. That the title Deputy Mayor/County Councillor be changed to Deputy Mayor
4. This By-Law shall come into force and take effect upon final passage of this by-law.
