A By-Law to repeal By-Law Number 14-14 Being a Bylaw to Provide for Fire and Emergency Services Fees and Charges


WHEREAS, Section 391(1) of The Municipal Act, S.O., 2001, as amended, provides for Municipalities to establish fees and charges for services or activities provided or done by the Municipality; and;

WHEREAS, it is necessary to increase a number of various fees for services and activities provided or done by the Municipality; and

NOW THEREFORE the Council of the Corporation of the Township of Clearview HEREBY ENACTS as follows:

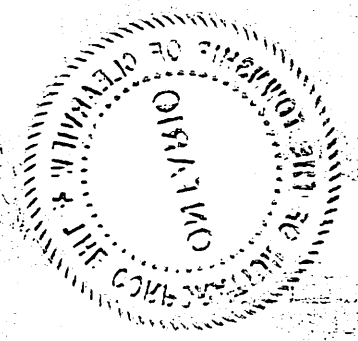
1. That the Fee for Service attached hereto as Schedule "A" forms part of this By-law.
2. That any current by-laws and any other by-laws or resolution or parts of by-laws or resolutions inconsistent with this bylaw are hereby repealed.
