

BY-LAW NUMBER 17-35

OF

THE CORPORATION OF THE TOWNSHIP OF CLEARVIEW

Being a by-law to establish lands within Registered Plan 111 (Nottawasaga) now in the Township of Clearview and to name the lands Sydenham Trail West


WHEREAS Subsection 11 (3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a lower-tier municipality may pass by-laws with respect to highways within its jurisdiction including a by-law to establish a highway for public use;


AND WHEREAS the Council of The Corporation of the Township of Clearview deems it expedient and in the interests of The Corporation of the Township of Clearview to confirm its jurisdiction and to establish the lands hereinafter described as public highways;

NOW THEREFORE the Council of The Corporation of the Township of Clearview enacts as follows:

1. THAT The Corporation of the Township of Clearview establish the lands more particularly described in Schedule "A" attached hereto and forming part of this By-law as part of the municipal highway system.
2. THAT the lands described in Schedule "A" be named Sydenham Trail West.
3. THAT this by-law shall come into force and effect immediately upon the final passing thereof.

By-law Number 17-35 read a first, second, and third time and finally passed this 24 day of April, 2017.
