


Notice of Completion Township of Clearview



Creemore Water and Wastewater Master Servicing Plan

The Study

The Township of Clearview has completed a Water and Wastewater Master Servicing Plan for the Village of Creemore. The Master Servicing Plan considered solutions for the long-term drinking water and sanitary wastewater servicing needs for the Community of Creemore and surrounding potential development opportunities.



The Process

The Study was initiated and conducted in accordance with the requirements of Phases 1 and 2 of the Municipal Class Environmental Assessment process (MCEA, October 2000 as amended in 2007 2011 and 2015) which is an approved process under the *Ontario Environmental Assessment Act*. The Master Plan uses Approach 2, which will allow for all Schedule B projects identified in the completed Master Plan to proceed to detail design. The study evaluated alternative solutions with consideration for the natural, cultural, technical and economic environment, and recommended preferred solutions in consultation with the public, Indigenous communities and regulatory agencies.

The Water and Wastewater Master Servicing Plan report is available for a 30-day review period from May 30, 2024 to July 2, 2024 in accordance with the requirements of the Municipal Class Environmental Assessment process.
